

**SuperSport Predictor Beyond the
90 Minutes Competition (DStv)
Mozambique**

1. These are rules for the SuperSport Predictor Beyond the 90 Minutes Competition (“**Competition**”) as conducted by MultiChoice Group and its affiliates (“**MultiChoice**”). By participating in the Competition, you agree that these rules, read together with the [Standard Terms and Conditions](#) will apply to your participation in the Competition.
2. The Competition will run from 00:00 hours on **25 May 2026** to 23:59 hours on **31 July 2026** (“**Competition Period**”).

3. Eligibility

3.1 To participate in the Competition, you must:

- Reside in Mozambique; and
- Be an active **DStv subscriber** during the Competition Period.

3.2 Disconnected subscribers may play and accumulate points but will **only qualify for prizes upon reconnecting their subscription during the Competition Period.**

4. How to Participate

4.1 Participants may access the SuperSport Predictor Game Hub (“**Gaming Portal**”) via any of the following entry points:

- MyDStv App - Banners
- SuperSport App - Banners
- SuperSport website - Banners
- Scanning QR codes displayed on promotional materials, including web banners, DStv interfaces, and on-screen TV placements. Access via QR code is subject to device compatibility and availability of a camera-enabled smartphone.

4.2 Upon accessing the Gaming Portal, participants shall:

- Register and/or log in to the Gaming Portal
- Play available games and challenges

5. Game Play

5.1 Available games include:

- Predictor games (match outcomes, scores, tournament progression)
- Trivia and quiz games
- Instant play games
- Daily, tournament, and milestone challenges

5.2 Participants earn **Game Points**, awarded immediately after game play. Game Points shall be awarded in

accordance with the criteria below:

6. Additional points

6.1 Game Points shall be accumulated together with the points detailed below (“**Additional Points**”) to arrive at the total points (“**Total Points**”).

6.2 Additional points shall be awarded based on the criteria below:

6.2.1 A maximum of 240 points for login streaks into the Gaming Portal. There are assigned days when login is rewarded. Should the subscriber fail to login on an assigned day, the streak resets to zero and the subscriber must reach the level they were at previously/ before losing points, in order to qualify for additional points.

6.2.2 Five (5) points for inviting a friend to register onto the Gaming Portal and participate in the Competition. A subscriber shall indicate the email addresses of referred friends and can earn up to a maximum of 50 points for ten (10) friends; and/or

6.2.3 A maximum of 500 points earned for watching specific matches on DStv stream. Up to 20 hours of viewing will earn a subscriber 100 points. Between 20 to 60 hours of viewing will earn a subscriber 250 points and more than 60 hours of viewing will earn a subscriber 500 points.

6.2.4 A maximum of 100 points earned for QR Code scanning during live match on DStv stream (5 points

each for a maximum of 20 scans).

7. Prizes

The top three (3) participants with the highest number of Total Points shall be eligible to the following prizes:

7.1.1 first prize (highest Total Points in the country) – 3 months of DStv Mega package at no cost

7.1.2 second prize (second highest Total Points in the country) – 2 months of DStv Mega package at no cost

7.1.3 third prize (third highest Total Points in the country) – 1 month of DStv Mega package at no cost

Prize acceptance and other terms

- 8 Prizes are not transferable and may not be deferred, changed or exchanged for cash or any other item. MultiChoice reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond MultiChoice make it necessary to do so.
