

## Open View

**Burundi, Cameroon, Cape Verde Congo, Cote D'Ivoire, Democratic Republic of Congo (DRC), Equatorial Guinea, Eritrea, Gabon, Gambia, Guinea Bissau, Guinea Conakry, Liberia, Mauritania, Mauritius, Niger, Sao Tome & Principe, Senegal, Seychelles, Sierra Leone, Somalia, South Sudan and Togo (DStv)**

1. These are rules for the Open View Promotion ("**Promotion**") as conducted by MultiChoice Africa Holdings B.V. ("**MultiChoice**"). By participating in the Promotion, you agree that these rules, read together with the [Standard Terms and Conditions \("\*\*Terms and Conditions\*\*"\)](#) will apply to your participation in the Promotion.
2. The Promotion will run from 00:00 hours on **01 June 2026** to 23:59 hours on **30 June 2026** ("**Promotion Period**").
3. By participating in the Promotion, eligible DStv subscribers ("**Eligible Subscribers**") will enjoy a higher bouquet at the price of their current subscription as explained below<sup>1</sup>.

### Eligibility and Access

4. To participate in the Promotion and qualify for access to the next higher package at the price of the current subscription you must, during the Promotion Period:
  - 4.1. be an active, new or disconnected DStv subscriber in either of Burundi, Cameroon, Comoros, Congo, Cote D'Ivoire, Democratic Republic of Congo (DRC), Equatorial Guinea, Eritrea, Gabon, Gambia, Guinea Bissau, Guinea Conakry, Liberia, Mauritania, Mauritius, Niger, Sao Tome & Principe, Senegal, Seychelles, Sierra Leone, Somalia, South Sudan, and/or Togo.
  - 4.2. make or have made payment in full for a package; or
  - 4.3. join as a new DStv subscriber and be entitled to access a DStv package; and
  - 4.4. watch DStv using an approved decoder or DStv stand-alone stream.
5. This Promotion will only be valid from the time you become an Eligible Subscriber as stated above until the end of the Promotion Period whereafter you will be reverted to the package paid for. Access to the next higher package shall end on **30 June 2026**, irrespective of the subscription end date.

7. Until indicated otherwise by MultiChoice, the Promotion is exclusive to linear decoder viewing and is not open to you, if, during the Promotion Period you are:
  - 7.1. an existing DStv subscriber on a Premium package;
  - 7.2. a DStv Business subscriber; and/or
  - 7.3. only a subscriber of a standalone package (such as Asian bouquet, Greatwall/China standalone bouquet, Asian add-on bouquet, French Plus add-on bouquet, French Touch add-on bouquet, Portuguese add-on bouquet and Add Movies add-on bouquet).
8. Your access to Catch Up (if applicable) shall be based on the package you have paid for.
9. It is your responsibility to ensure that payment of the subscription fee in respect of any package eligible for this promotion as indicated in paragraph 6 above is received by MultiChoice. Without limitation, MultiChoice is not responsible for any difficulties encountered with third party merchants nor for any costs that you may incur to participate in this Promotion.
10. Subject to system dependencies, the new package may be effected within 48 hours of receipt of payment by MultiChoice as set out herein. If the access to the next higher package is not effected, MultiChoice will endeavour to effect the same within the shortest possible time following notification by you.
11. Additional products such as add-ons and Value-Added Services (such as Xtra View and HD PVR access) are not included in the Promotion and the normal billing rules apply in this regard. If required, you will have to make separate payments for the add-ons at the published rates in order to enjoy the add-ons alongside the granted higher package. In respect of the Value-Added Services, you will need to make payment in full for these in order to avoid being disconnected.

For subscribers with companion DStv stream, subject to system dependencies, the new package on the companion DStv stream may be effected within 48 hours of enabling the access on the decoder viewing. If the access to the next higher package is not effected on the companion DStv stream, MultiChoice will endeavour to effect the same within the shortest possible time following notification by you.

#### **Other terms**

13. MultiChoice shall not be liable for any failure to comply with its obligations where the failure is caused by circumstances outside its reasonable control.
14. The rule of construction that the Terms and Conditions will be interpreted against the party responsible for the drafting or preparation of this document and the Terms and Conditions will not apply.
15. MultiChoice may cede, assign or novate any or all of its rights and/or any or all of its obligations set out herein and/or in the Terms and Conditions to any person or entity without notice to you.
16. MultiChoice reserves the right to suspend or stop your participation in the Promotion if you are involved in fraud or manipulation of the process.
